# Farm Campground Rules and Regulations

## General Campground Rules

### 1. Check-In and Check-Out Times

- There are no specific times, just be reasonable and keep us informed.

### 2. Quiet Hours

- If it's empty there are no quiet hours but if not then please respect your neighbors by keeping noise to a minimum during these hours, or otherwise invite them over.

### 3. Campfire Regulations

- Campfires are only allowed in designated fire pits.
- No open flames or bonfires are permitted outside of these areas.
- Always extinguish fires completely before leaving your campsite.

### 4. No Burn Rules

- **No Burning of Trash:** All trash must be disposed of in designated bins. Burning trash is strictly prohibited.

- **No Burning of Wood from Outside Sources:** To prevent the spread of pests and diseases, only firewood purchased on-site or approved by campground staff may be burned.

- **Burn Ban:** During periods of high fire danger (usually indicated by local authorities), all open flames, including campfires and charcoal grills, may be prohibited. You can find this out on [https://www.dnr.state.mn.us/forestry/fire/firerating\\_restrictions.html](https://www.dnr.state.mn.us/forestry/fire/firerating_restrictions.html) and looking for Pine County, or by asking us.

### 5. Pet Policy

- Pets are allowed but must be kept on a leash if they are likely to chase people, pets, or farm animals.
- Owners are responsible for cleaning up after their pets.

## **6. Alcohol Consumption**

- Alcohol is permitted but must be consumed responsibly. Excessive noise or disruptive behavior will not be tolerated.

## **7. Vehicle Regulations**

- Speed limit within the campground is 5 mph.  
- You can drive across the field and park at your campsite but please check with us first so that we can guide you as to the best route. We will not take responsibility for vehicles that get stuck, although we will endeavor to pull you out with a tractor if you ask nicely,

## **8. Respect Wildlife**

- Feeding wildlife is prohibited. Keep food stored securely to avoid attracting animals.  
- Observe wildlife from a distance and do not approach or attempt to touch them.

## **9. Safety and Emergency Procedures**

- Report any suspicious activity to campground staff immediately.

## **10. Respect Other Campers**

- Be courteous to fellow campers. This includes respecting privacy and personal space.  
- If you have a complaint, address it with campground management rather than confronting other campers directly.

## **11. Bathrooms**

- We currently don't have these so you must provide your own toilet facilities. We can not legally permit you to pee or poop in the woods.
